



### General Information

Full Name:	The person's first and last name, and middle name (if applicable). It is the most current first and last name that the College has on file for the person.
Registration Number:	The number assigned to the person's Certificate of Registration. The number is unique for each Certificate of Registration issued by the College.
Certificate Issued Date:	The date on which the person was issued a Certificate of Registration with the College or re-issued their Certificate of Registration with the College upon reinstatement.
Registration Status:	<p>The <b>current</b> status of the person's Certificate of Registration with the College. There are different types of statuses.</p> <ul style="list-style-type: none"> <li>• Current Member</li> <li>• Current Member Subject to Terms, Conditions or Limitations</li> <li>• Expired</li> <li>• Interim Suspension</li> <li>• Resigned/Cancelled</li> <li>• Revoked</li> <li>• Revoked by an Order of a Committee</li> <li>• Suspended by an Order of a Committee</li> <li>• Suspended for failing to comply with continuous professional learning requirements</li> <li>• Suspended for Non-Payment of Fees or Penalties</li> <li>• Suspended for Failure to Provide Information</li> </ul>
Effective Date:	The date on which the person's registration status took effect.
Class of Certification of Registration:	The College only has one class of certificate: General.

### Terms, Conditions & Limitations

The terms, conditions, and limitations (TCLs), **if any**, that are **currently** imposed on the person's Certificate of Registration. This means by law that the person may only practise the profession within the TCLs imposed on their Certificate of Registration.

The TCLs are unique to the person's Certificate of Registration.

TCLs may be imposed:

- by the College's Discipline Committee, Fitness to Practise Committee, or Registration Appeals Committee,
- by the College's Executive Committee,
- by the College's Registrar, or
- as a result of a written undertaking or other agreement between the College and the person.

### Special Notices

Additional information about the person, **if any**, related to the following matters.

- Referrals made to the College's Discipline Committee. This means that a matter has been referred to the College's Discipline Committee but a hearing by the Discipline Committee has yet to occur, or is in progress.
- Decisions made by the College's Discipline Committee.
- Decisions made by the College's Complaints Committee, **only** if an agreement is made between the College and the person that directs that information be included in the public register.
- Findings of incapacity made by the College's Fitness to Practise Committee.
- Information that a Committee of the College directs to be included in the public register.
- **If known to the College**, restrictions imposed by an order of a court or other lawful authority on the person's eligibility to practise the profession.
- **If known to the College**, current or previous criminal proceedings involving the person that are relevant to their membership with the College.
- Information the College and person have agreed should be included in the public register.
