

Types of Registration Status

The Public Register includes information on the status of a member's Certificate of Registration. Here are the different types of statuses and what they mean.

The following statuses indicate that a member is permitted to practise and is allowed to use the designations registered early childhood educator (RECE), early childhood educator (ECE) or their French equivalents.

Good Standing: Signifies the individual:

- has met the requirements for registration with the College and been issued a Certificate of Registration;
- has paid all applicable fees; and
- is in compliance with annual reporting requirements, including Continuous Professional Learning (CPL).

Good Standing Subject to Terms, Conditions or Limitations: Signifies that the individual is a member in good standing but that their Certificate of Registration is subject to Terms, Conditions or Limitations imposed by the Registrar or by order of a College Committee.

The individual is permitted to practise the profession only within the scope permitted and in compliance with the Terms, Conditions or Limitations.

The following statuses indicate that an individual is not permitted to practise and may not use the designations registered early childhood educator (RECE), early childhood educator (ECE) or their French equivalents.

Suspended: Signifies the individual was once a member in good standing but their Certificate of Registration has been suspended. **Professional misconduct committed by suspended members can still be investigated by the College and should be reported**.

Suspensions may be imposed for the following reasons:

• Suspended for Non-Payment of Fees or Penalties: Certificate of Registration has been suspended for non-payment of annual membership fee and/or penalties required by the College's bylaws.

- Suspended for Failure to Provide Information as Required by the College: Certificate of Registration has been suspended for failure to provide information. Some examples of information required by the College include annual renewal declaration forms, employment information, and declaration of compliance with CPL Program requirements.
- Suspended for Failure to Comply with Continuous Professional Learning (CPL) Requirements: Certificate of Registration has been suspended for failure to comply with the requirements set out in the Continuous Professional Learning regulation or the College's Notice of CPL Program Requirements.
- **Suspended by Order of a Committee:** Certificate of Registration has been suspended for a specific period as a result of a decision of a College Committee, usually in relation to a professional misconduct or incapacity issue.

Revoked: Signifies that the individual's Certificate of Registration has been administratively revoked. This occurs when a member was initially suspended as a result of non-payment of fees, failure to provide information required by the College or failure to comply with Continuous Professional Learning requirements, *and* the person did not apply for reinstatement within three years of the suspension date. After three years, the Certificate is automatically revoked.

Revoked by an order of a Committee: Signifies that an individual's Certificate of Registration was revoked as a result of a decision by the Discipline Committee or the Fitness to Practise Committee of the College following findings of professional misconduct, incompetence or incapacity.

Resigned/Cancelled: Signifies the individual was once a member in good standing and has resigned their membership, or retired from the profession and their Certificate has been cancelled.
